Policy regarding the processing of personal data for event registration Multisport Experience - version 1 - June 14, 2018

Event registrations

Before registering for an event organized by the Multisport Experience, please read the information presented here and the registration will be made if we have your consent regarding the proposed data processing policy.

Who we are

Association Sport Club Multisport Experience, based in Arad, Cathedral Square, no. 6, ap. 13, CIF 31021976, as personal data operator, according to Regulation 679/2016 of the European Parliament and of the Council of the European Union of April 27 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data ("GDPR").

What data do we collect from you by registering

We collect the data you enter: name, first name, address, email, telephone, date of birth. Optionally you can enter: occupation, competitions in which you participated, the tutor, the represented structure, the educational institution (in the case of students, students). The registration system collects from you and the date / time you registered. How we use the data collected by registering for the event

The information you enter is used for the general running of the event, as follows: drawing up and displaying the list of participants, displaying the list of results, validating entries, handing over event numbers and chips, where appropriate, preparing digital timing systems, where appropriate, preparing the numbers associated with the registered persons, reporting the progress of the event to funders, public institutions and private structures, the use of accounting, legal or financial services, upon the justified request made by the public structures involved in running the event, directly or indirectly, other operations necessary for the development of the event in good condition for the event and for archiving the event.

Use of cookies

We use cookie technology either directly or with the support of our suppliers and partners. What rights do you have?

Once registered, you can exercise your rights specified by Regulation 2016/679 by sending an email to us, as an operator, at experientamultisport@gmail.com. Your rights are: the right of access to personal data, the right to rectify data, the right to delete processed data (the right to be forgotten), the right to request the restriction of the processing of your personal data (the right to oppose), the right of data portability, the right to the opposition and the right to address a complaint to the National Supervisory Authority for the Processing of Personal Data, if you consider that your rights have been violated.

Withdrawal of consent

Who has access to the data sent, when transferred outside the EU / EEA area
